Essential Qualification and eligibility criteria requirements:

(a) Must have Ph.D. degree in relevant field.

AND

(b) Must have First Class or equivalent either at Bachelors or Masters level in the relevant branch (60% marks or 6.75 CGPA in aggregate shall be considered equivalent to first class if first class or division is not awarded by the concerned institution).

AND

(c) Must have minimum 10 years of experience in Teaching (In UGC & AICTE approved institutions) / Research / Industry.

AND

(d) Out of 10 years of experience minimum 03 (Three) years of experience should be as Associate Professor or equivalent.

AND

(e) Must have at least 06 numbers of research publication at the level of Associate Professor in SCI / UGC / AICTE listed Journals and must have successfully produced at least 02 Ph.D as Supervisor / Co-Supervisor as on the last date of application.

OR

Must have at least 10 research publications at the level of Associate Professor in SCI / UGC / AICTE listed Journals as on the last date of application.

Desirable Qualification:

Must have at least a total Research Score of 120 (One hundred twenty) on the last date of application (as per Appendix-II, Table-2 of UGC Regulations vide UGC Notification No. F.1-2/2017(EC/PS) dated 18/07/2018).

(b) Must have First Class or equivalent either at Bachelors or Masters level in the relevant branch (60% marks or 6.75 CGPA in aggregate shall be considered equivalent to first class if first class or division is not awarded by the concerned institution).

AND

(c) Must have minimum 08 years of experience in Teaching (In UGC & AICTE approved institutions) / Research / Industry.

AND

(d) Out of 08 years of experience minimum 02 (Two) years of experience should be Post Ph.D experience.

AND

(e) Must have at least 06 numbers of research publication in SCI / UGC / AICTE approved listed Journals.

Desirable Qualification:

At least a total Research Score of 75 (Seventy five) on the last date of application (as per Appendix-II, Table-2 of UGC Regulations vide UGC Notification No. F.1-2/2017(EC/PS) dated 18/07/2018).

Application Fees:

A candidate is required to pay a non-refundable and non-adjustable fee of Rs.1000/- (Rs.500 for ST/SC category) through SB Collect.

Step 3- From "Type of Corporate / Institution", select-> "Educational Institution"

Step 4- From "Educational Institutions Name", Select-> "Biju Patnaik University of Technology, Rourkela"

Step 5- From "Select Payment Category", select-> "Recruitment"

After transaction / payment, the payment slip needs to be attached with the application.

The applications will be accepted only by Speed Post; No Hand Delivery or any other mode is acceptable. In-service candidate(s) need to forward his/ her application through the employer or need to submit a 'No Objection Certificate' from the employer at the time of interview. The sealed envelope containing the application form and other documents should be super-scribed as "Application for the post of Professor (OR Associate Professor) in (Name of Department/Specialization), IMIT, Cuttack" and reach to Registrar, BPUT, Chhend, Rourkela -769015 on or before 09.08.2019. Minimum eligibility does not ensure that a candidate will be called for interview and/or selected; the decision of the university authorities is final. No correspondence in this regard shall be entertained.

General Information:

- Separate applications with separate application fees in separate envelopes must be submitted, if a candidate is applying for a faculty position in more than one post and department.
- 2. Mere fulfillment of qualifications, eligibility and experience requirements etc. does not entitle a candidate to be called for an interview.
