Applications are invited from eligible candidates for the post of Junior Laboratory Technician and Attendant for appointment on contractual basis under "New Recruitment Policy" as laid down in the Odisha Group-C and Group-D post(Contractual appointment) Rules,2013 notified by G.A.Department vide Notification No 32010/Gen dt 12.11.2013. The condition of Service and monthly remuneration of Contractual Employees to be appointed to such posts shall be regulated as per rules and provisions laid down in the said Notification of G.A.Department. The applicants presently working in similar assignment under any Scheme of H&FW Department shall be allowed age relax below the age of 45 years and have completed at least one year of continuous service shall be allowed to take part in the recruitment process and weightage will be given as per rules stipulated in the above said G.A.Notification. The applicant being citizen of India with knowledge of Odia as laid down in the respective Cadre Rules have equal right to take part in the recruitment and to be selected on merit basis as provided therein for Deogarh district and question of preference to local candidates does not arise. NB: - Reservation for Person with Disability & Ex-Service man etc. will be made as per the guidelines of GA Department and relevant rules.

Reservation:-

The reservation of vacancies or posts shall be made as per rules made by Govt. from time to time to that effect under ORV Act and Rules as stipulated in G.A.Deptt. Notification No 1147 dt 17.1.2014 and No 32010 dt 12.11.2013.

Eligible Criteria:-

- (i) Nationality:-He/she must be a citizen of India.
- (ii) Age limit:-The candidates must have attained the age of 21 years and must not be above the age of 32 years as on 15.12.16 for Lab. Technician and in case of Attendant he/she must have attained the age 18 years and must not be above the age of 32 years as on 15.12.2016. The upper age limit shall be relaxed by 5 years in case of women, SC, ST candidates and 10 years in case of Person with Disability. All candidates being women shall be allowed relaxation of upper age limit in accordance with provisions of the relevant Rules as may be decided by the Government from time to time. Persons who comes under more than one reserved category, shall be eligible for only one benefit to relaxation which shall be considered more beneficial to him/her. The upper age relaxation in case of Ex-Service Man will be given as per rule. The applicant those are working in similar assignment under any scheme of H&FW Department shall be allowed age relaxation and mark weight age as per rule stipulated in the GA Deptt Notification No 1147 dt 17.1.14 and 32010 dt 12.11.13. Further that the candidates engaged on contractual basis under the Central Plan Scheme, State Plan Scheme and externally aided Scheme who are below the age of 45 years and have completed at least one year of continuous service shall be allowed to take part in the recruitment process for filling up the above post.
- (iii) For the post of Jr. Lab. Technician:-
 - (a) the candidate must be able to read, write and speak Odia.
 - (b) Passed middle school examination with Odia as language subject or
 - (C) Passed Matriculation or equivalent examination with Odia as medium of examination in non language subject or
 - (d) Passed in Odia as language subject in the final examination of Class-VII from a school or educational institution recognized by the Government of Odisha or the central Govt. or
 - (e) Passed a test in Odia in Middle English School standard conducted by the School and Mass Education Department.
- (iv) **Marital Status**
If married, the candidates must not have more than one spouse living except otherwise exempted by Government.

v. Physical Fitness

The candidates must be of good mental and physical health and free from any physical defect likely to make him/her incapable of discharging of the normal duties in the service.

Recruitment Procedure

Recruitment of Lab. Technician posts shall be made on merit basis by way of Carrier Assessment of the candidates by the Board as below:-

For the post of Attendant he selection will be made on the basis of mark secured in 07 th pass certificate. The 07 th pass certificate and mark sheet must be verified by the Block Education Officer and then be countersigned by the concerned Dist.Education Officer prior to issue of appointment order.	

The candidates engaged on contractual basis for both the post under the Central Plan Scheme, State Plan Scheme and externally aided Scheme shall be allowed 1% extra mark of the total marks of examination for each completed year of continuous service subject to maximum of 15 % which will be added to the marks secured by them for deciding the merit position for the post of Lab. Technician only.

3. Selection will be done strictly on the basis of merit as per Carrear assessment for the post of Lab. Technician and no weightage will be given for higher qualification.
